### 2. Presidential report

### 3. Treasurer's Report

1. For the financial year ending 31 March 2018 the net assets of the Association comprised \$62,334.21, which includes our term deposit of \$11,224.37

2. The Association operated at a loss for the financial year of \$5,226.37. The main expenditure was around the 2017 Conference which generally broke even, the upgrade of the website, the Council offsite meeting, and the editing of the NZPR. The bulk of our income was obviously from the 2017 Conference registrations and sponsorships.
3. PANZ is in a strong financial position, however as a Tier 4 non-profit organisation we are holding more funds than we require for our day-to-day administration, so an operating loss is not of a concern at this stage. A reduced subscription rate (proposed for this AGM, \$30 instead of the current annual fee of \$45) versus the number of financial members (which is slowly decreasing) will still provide coverage of our operating costs going forward, especially as the NZPR costs reduce with the move to the electronic edition.

**Points raised (at the AGM on 5<sup>th</sup> July 2018 which had to be reconvened):**

- Tahu Kukutai raised the point that it is a struggle to get people especially academics to contribute to the NZPR keeping in mind their PBRF considerations. With NZPR going digital, there is probably more scope to promote the journal version more heavily with the added ability to monitor and having more transparency around individual article downloads even if they are not cited. Moore needs to be done to promote NZPR.

**4. Subscriptions**

1. That the annual ordinary membership fee be changed to \$30 for the 2019/2020 financial year and beyond.
2. That for the 2019/2020 financial year and beyond, associate members are not required to pay a subscription fee but are entitled to reduced conference registration fees as determined by Council.
3. That the membership definitions as prescribed in the PANZ Constitution remain unchanged.

- Comms and activities between conferences

Kim Dunstan raised the point that he (and members) would like to hear more from PANZ between conferences about what's happening not only within PANZ but across the wider demographic community. It will good to get out some of the discussions that happen within the council which can help PANZ become vivible and attract more membership. It will good to 'resurrect' the 3-monthly mewsletter.

Rosemary clarified that the council is looking to re-start the newsletter and upload it on the new PANZ website. For activities in between conference years, the council is happy to get suggestions and ideas from members. This point raised by Kim will be discussed at the first council meeting after the AGM.

- Tahu Kukutai brought forth a point to be discussed at the next council meeting – about PANZ as a professional association playing a more active role

With major shift in the 2018 Census methodology and with early results suggesting that we could be facing some pretty major impacts on the census data. This is an important issue that PANZ needs to be acknowledging, speaking about and providing some clarity on. The issue of many council members being Stats NZ employees and cannot be publically seen as making any statements on this topic which could be seen as contentious also needs to be taken into account. This needs to be discussed in the council meeting whether we as a council see PANZ having a role in making any public comments on the census.

## **APPENDIX B – TREASURER’S REPORT 2018/19**

### **Financial Statements**

**For Year ended 31 March 2018**

#### **Treasurer’s Report**

As the 2017/2018 financial year included the 2018 New Zealand Population Conference income and expenditure was increased on the previous financial year. Whilst the main expenditure was around the 2017 Conference – which generally broke even despite a low level of corporate sponsorship – the upgrade of the PANZ website, the Council offsite meeting and the editing of the NZ Population Review, which has now gone digital, contributed to the final operating loss of \$5,226.37 for the year. The bulk of income was from 2017 Conference registrations and sponsorships whilst subscription income remained reasonably consistent with the previous financial year.

The financial statements of the Population Association of New Zealand for the year ended 31 March 2018 have not been audited as under the reporting requirements from the Charities Commission, PANZ is a Tier 4 level organisation and as such no legal requirement for an audit is required.

As at 31 March 2018, the Population Association of NZ had net assets of \$62,334.21 consisting of transaction account, term deposit of \$11,224.37 and accounts payable of \$1,012.50. Note that the account payable amount is retained due to an issue in utilising the accounting software and is not an outstanding payment. Despite noting in last year’s report that this was corrected, there has been an ongoing issue with the accounting software which is awaiting resolution via consultancy with Cognito.

The Population Association of New Zealand remains in a strong financial position in the year to March 2018. However, as a Tier 4 non-profit organisation the Association is holding more funds than required for its day-to-day administration. Whilst membership is decreasing, and subscriptions rates are proposed for reduction in the 2019/20 financial year, the reduction in operating costs going forward requires some consideration on the best usage of existing funds.
