APPENDIX B - TREASURER'S REPORT 2019

Population Association of New Zealand Financial Statements For Year ended 31 March 2019

As the 2018/19 financial year was a non-conference year income and expenditure was down. The main expenditure was around the editing of the NZ Population Review and the Council's strategic planning workshop which contributed to the final operating loss of \$4,091.79 for the year. The bulk of income was from subscription income which remained reasonably consistent with the previous financial year, noting that the 2018 AGM approved a reduction in subscription rates for the 2019/2020 year.

The financial statements of the Population Association of New Zealand for the year ended 31 March 2019 have not been audited as under the reporting requirements from the Charities Commission, PANZ is a Tier 4 level organisation and as such no legal requirement for an audit is required.

As at 31 March 2019, the Population Association of NZ had net assets of \$58,242.42 consisting of transaction account, term deposit of \$11,224.37 and accounts payable of \$1,012.50. Note that the account payable amount is retained due to an issue in utilising the accounting software and is not an outstanding payment.

The Population Association of New Zealand remains in a strong financial position in the year to March 2019. However, as a Tier 4 non-profit organisation the Association is holding more funds than required for its day-to-day administration.
