APPENDIX A – PRESIDENTIAL REPORT 2020

Thursday, 24th June 2021

Warm greetings to you all, and welcome to the 47th Annual General meeting of the Population Association of New Zealand, (2021). Again we seem to have experienced a tumultuous year, although Aotearoa has been somewhat sheltered from the worst of world events though the quick actions of our government. However, the events of the last few days have reminded us again of the fragility of our safety as well as the need for tolerance and understanding of others. The experiences of the last year will be recorded in statistics and discernible for later generations – just as we have looked at population pyramids and observed the effects of the flu epidemic of 1918/19, and the world wars. In the abstract they remind us of the importance of recording and understanding the impact of world events. Here we have seen net migration plummet while an almost non-existent flu season may have protected some of the vulnerable elderly. And contrary to predictions of commentators we have not seen a post-Covid baby boom. Overseas we have seen and will continue to see the deadly impact of disease, and the inequality with which it has affected countries and people within these countries. But we don't experience such events in the abstract – and the reality is a difficult one. In a country as connected as ours the events of the last year have also meant families separated, temporary migrants stranded in limbo – afraid to leave and uncertain of the future. Many families and whanau will have experienced concern for loved ones overseas, some of whom who may have become ill or died either from Covid-19 or the disruption to health care systems.

While these have been difficult times, we have also seen the work of some amazing people in this country. I think it is important that we celebrate the work of such people and so I am delighted that at this meeting we will be proposing another life member of the association in recognition of many years of dedication to the association and demographic research. We will discuss the proposal for life membership a little later in the agenda.

Now I will discuss some of the work of the association over this last year as well as acknowledge the work of those people who keep the association running. The two main areas that the Association concentrates on are the biennial conference and the New Zealand Population Review. Work is well underway around the conference and the work of the journal is ongoing.

The 2021 conference: Council committee members met in Auckland in March to sort out the logistics of the conference and to confirm themes and keynote speakers. Our conference this year will explore some of the issues of inequality that the pandemic has highlighted, as well as a range of other topics related to population. I am thrilled at the range and quality of our keynotes and look forward to welcoming you in September. We keep our fingers crossed that it all goes smoothly and there are no crises. Keep using the COVID tracer app!

The journal: I would like to acknowledge the work of Tahu Kukutai who has been an amazing editor of the journal and has stepped down this year. Thank you so much for your dedication and expertise. The 2020 issue was published earlier this year – a little late

largely owing to Covid. It includes some great articles so I encourage you to check it out on our website. I would also like to thank Bryndl Hohmann-Marriott who is thankfully continuing on as a journal editor as well as myself, and Alison Reid for her ongoing assistance with formatting. We also have a special issue on housing which will be published soon, with our guest editors Kay Saville-Smith and Grace Walker. I am delighted to report that the abstracts and editorial for the latest issue are currently being translated into Te Reo and we plan to make this a regular part of the journal. I also wish to give a special thanks to all our peer reviewers whose expertise ensures the quality of articles but also provides valuable insights to journal submitters.

Issues raised last year: Last year a couple of issues were raised – Tahu Tahu Kukutai raised a question about correctness of the Maori name of PANZ (Whakawaihanga) and this has been changed on the website. However, we were going to set a group to rethink the nature and objectives of the constitution – this is something we need to progress further. I would like to thank the wonderful members of our committee. Our new members Niyi and Isaac have been working hard on the conference as well as exploring ways to improve the reach of the association. Thanks to our secretary Shefali, Tze Ming for running our website, our Treasurer Andrew for his work on the accounts and in updating the constitution, Arvind for his wisdom and knowledge of PANZ, Mike for his energy and enthusiasm, and Rebekah for representing population statistics.

I also want to thank all the members of the Association for your ongoing support. Keep safe and I look forward to welcoming you to the 2021 conference. Let us know if want to be involved in the committee in the future. And remember that the NZ Population Association is an organisation dedicated to promote understanding and research around populations. The work of our members and other researchers will help inform the debates and discussions around the restless and uncertain world in which we are living.

APPENDIX B – TREASURER’S REPORT 2021

Population Association of New Zealand Financial Statements For Year ended 31 March 2021 Treasurer’s Report

The 2020/2021 financial year was a non-conference year for PANZ so there was limited income and expenditure generated. Total income of \$2,317.10 was primarily made up of subscription income noting that changes to the membership categories were approved by the 2020 AGM. These changes may result in further reduced income in the next financial year.

Expenditure primarily related to website and email costs, the editing costs of the NZ Population Review, Council travel, Royal Society membership fees, and bank fees. General expenditure going forward has been reduced by the closure of the PANZ Post Box, and by terminating PANZ email account support with Actrix/Voyager in favour of a free service through Google. The digitization of the NZ Population Review has further reduced expenditure.

PANZ terminated its term deposit with Kiwibank on its maturity date in February 2021 transferred the full funds plus interest into its transaction account.

The financial statements of the Population Association of New Zealand for the year ended 31 March 2021 have not been audited as under the reporting requirements from the Charities Commission, PANZ is a Tier 4 level organisation and as such no legal requirement for an audit is required.

As at 31 March 2021, the Population Association of NZ had net assets of \$49,133.43 solely residing in a transaction account with Kiwibank. The Association ran at a loss of \$695.72 for the year ending March 2021.

The Population Association of New Zealand remains in a strong financial position in the year to March 2021. However, as a Tier 4 non-profit organisation the Association is holding more funds than required for its day-to-day administration.

Dr Robert Didham is an internationally recognised and prominent researcher in the field of population studies and is a prolific author on topics such as ethnicity, migration, identity and demography. He has authored or co-authored more than 50 papers, including recent work on ethnic mobility. His interests also include history, Asian languages, and Buddhism. He reads, speaks and writes numerous languages, especially those with their roots in Sanskrit. Robert is something of a modern-day polymath with very wide-ranging intellectual interests and skills. Robert has seven degrees, including two PhDs, and reads around 60 different languages. He has long been a stalwart support of the local Cambodian community in Christchurch.

A long-standing member of the Population Association of New Zealand, Robert has worked at Statistics New Zealand for over 28 years and is a well-respected colleague, expert, mentor and authoritative voice to all who work with him. His detailed knowledge of a wide range of topics, data and Census is unparalleled. During those 28 years Robert has always pursued research and a key feature of his research has been collaboration with colleagues in the universities and the private sector. One only has to look at Robert's list of publications to see the extent of his contributions to the research of his colleagues across a wide range of critical conceptual, methodological and substantive population issues. These contributions are clearly recognised in his role as Research Associate at NIDEA, where he has enriched teaching and research through his ongoing collaboration with NIDEA researchers, providing guest lectures and technical support to graduate students. His wisdom and sage advice is always given from the heart and is given in a way that all can understand, whether student, researcher or expert alike. He is a stalwart of supporter of the New Zealand Population Review both as a contributor and an enthusiastic and supportive peer reviewer. Robert is a very worthy candidate for life membership of the Population Association of New Zealand.
